SENIORS FOR SOCIAL ACTION (ONTARIO) PARTNERS WITH UNIVERSITY RESEARCHERS

Seniors for Social Action Ontario (SSAO) Joins the University of Manitoba in an Innovative Research Partnership

In June, the Board of SSAO struck an Ad Hoc Advisory Committee to provide advice to University of Manitoba researchers examining Care Poverty in Canada. The concept of care poverty was first introduced by Professor Teppo Krogen at the University of Jyväskylä in Finland. Dr. Krogen's book is available on open access here: https://link.springer.com/book/10.1007/978-3-030-97243-1

The University of Manitoba has done some excellent research that has been of interest to SSAO in the past, and researchers there have been respectful of elders' input into research initiatives for some time now.

This is one of the first formal partnerships between a seniors' organization and university researchers to examine an issue of significant importance to elders and their caregivers across Canada.

RESPONSE TO QUESTIONS FROM MEMBERS

Why Are SSAO Admins Anonymous?

Some have asked why, when they contact SSAO, they hear from an anonymous Admin. In the past, when Kay Wigle, now deceased, was our admin, people managed to track her down and call her at home. In some cases, as we all know, members of the public can also be less than respectful in their interactions with organizations.

Since all of SSAO's volunteers are in our 70's and 80's, and giving generously of our time to advance the perspectives of our membership and respond to members' questions and concerns, we have made the decision to protect admin's identities.

Admins are well versed in the issues SSAO takes up and make appropriate referrals to the Chair or other SSAO members when specific or specialized information is requested.

Why Are Some of SSAO's Articles Unsigned?

SSAO volunteers have also, and continue to, engage in research and in developing and analyzing public policies, and write editorials and articles that are sent to our members. In some cases, where there has been quite broad consultation on an article or editorial, or several contributions, all of the contributors are not named, so the article is not signed by an "author".

Wherever possible, if there has been a lead author or authors, that person or persons are named. All guest contributors are also named.

SENIORS FOR SOCIAL ACTION ONTARIO CO-FOUNDERS – WRITING FOR CHANGE

In March, 2020, twelve elder and disability activists came together to form Seniors for Social Action Ontario to begin to address the tragedy unfolding in long-term care institutions. Many had significant experience in successfully advocating for, and

developing alternatives to large institutions for labeled and vulnerable people. Since then over 1500 members from every part of Ontario have joined SSAO to promote alternatives to institutions in their local areas. Many are also affiliated with other organizations with similar goals, such as Councils on Aging.

For over four years co-founders of SSAO have produced articles and editorials, and taken part in advocacy with government and the Opposition to advance the cause of aging in place and in community. SPECIAL TRIBUTE TO SSAO CO-FOUNDERS WHO HAVE PASSED

At this time we also remember with respect Kay Wigle, Don Weitz and Sparky Johnson, co-founders of SSAO who have passed since the organization was formed. All put their hearts and souls into effecting change for older adults. May they rest in peace and their memories be a blessing.

Kay Wigle passed at the age of 67 in 2021. Her death was a devastating blow to all of us at SSAO. She was a tireless and effective advocate for people with disabilities and elders, and an excellent spokesperson and admin for SSAO. She was also a prominent labour activist in London. Kay was always upbeat and encouraging to all of us and we will miss her to the end of our days. Don Weitz, another founder of SSAO and mental health activist, also passed in 2021 at the age of 90. Don fought the forces of oppression of people living with mental health challenges his whole life and was an important voice within this organization. We all greatly miss Don's humor, caring, and determination and especially his wise counsel about people with mental health issues facing mistreatment in the long-term care system. Sparky Johnson, an Indigenous long-term care activist, was a warrior for justice in every sense of the word. We lost her at the young age of 52 in 2022. Sparky organized numerous demonstrations in front of nursing homes across Ontario to bring awareness of the conditions there. She was someone who never gave up and could always be counted on to support SSAO's advocacy efforts.
